The Faire hours are Saturday from 10:00am to 5:00pm and Sunday from 10:00am to 4:00pm. You may start setting up as early as 9:00 am both days and cleanup will begin promptly at the end of each day.

You will be provided with a table (or a ½ table section) and chairs to use. We will provide some sort of table covering/cloth for your spot, and you are also welcome to bring your own. It is up to you whether or not you decide to leave your product display in the gym overnight. The facilities will be locked, but the H&SC assumes no responsibility for possible loss or damage.

Rules to note:

1. All items for sale must be hand-crafted, no completely pre-manufactured items may be resold.
2. Student vendors may not sell baked goods (i.e. cookies, muffins, breads, cakes, etc.) or holiday wreaths, as this conflicts with the school bake/wreath sale at the event that is raising money for the CTE D.C. trip.
3. Please do not begin your crafting until your application has been accepted and approved via email. For the benefit of all the student vendors, we aim to limit the number and type of each similar product for sale. Priority for specific products will be given to last-year's vendors.
4. There is a limit of two students per ½ table space.
5. Please be courteous to all other participating vendors. No wandering throughout the faire selling products or soliciting customers, please remain at your table space with your items.
6. Be sure to bring some spare cash/change that may be necessary for your customer's purchase(s).
